## **Covid-19**

## **About Us**

---

The Mayflower Council, Scouts, BSA of America, provides educational programs that build character, teach participatory citizenship and develop personal fitness.

This will be our 6th year as a coed camp. We are ready to help both boys and girls complete their Cub Scouts.

Cub Scouts (boys and girls ages 6 to 10), Scouts, participate in action-oriented programs that fulfill the aims of Scouting.

### **Facilities**

The Council's three camps, the E. Paul Robsham Scout Reservation (Camp Resolute & Adventure Day Camp), Nobscot Scout Reservation, and Camp Squanto offer Scouts more than 1450 acres of beautiful forested land and wilderness for a wide variety of outdoor programs including camping, hiking, swimming, boating, rappelling, rock climbing, ropes courses and horseback riding.

### **Area-Served**

The Council's geographic area includes 61 cities and towns in Massachusetts. Approximately 2,000 young people participate in Council Scouting programs on an annual basis. More than 2,000 adult volunteers provide leadership for 200 units — Camper packs, Boy Scout troops and Venturing crews. Units are licensed or chartered to community organizations, such as schools and churches. In addition, we host

campers from outside the Mayflower Council community.

## **Adventure Day Camp**

---

The E. Paul Robsham, Jr. Scout Reservation – Adventure Day Camp and Camp Resolute are American Camp Association Accredited.

The Day Camp Program provides an introduction to Scouting's Outdoor Program. Activities are conducted in an outdoor setting, close to home and during daylight hours. Our day camp programs are designed for boys and girls completing grades 1 through 7.

The program provides an opportunity for continuation of the Camper program and advancement throughout the summer. Program activities include; swimming, boating, fishing, crafts, hiking, biking, nature study, games, field sports, team building activities, archery, and BB gun shooting. Older campers partake in age appropriate activities as well, like Stand-Up Paddle Board and Merit Badge Classes.

Campers participating in Day Camp are better prepared and eager to accept the challenge of residential camping. Adventure Day Camp is not attended as an advancement camp. Instead, through supervised activities, boys and girls develop self-reliance and resourcefulness, learn age appropriate skills, establish new friendships and, of course, have lots of FUN.

Camp activities are age-appropriate. Campers will be placed in dens with boys or girls of the same age and with campers from their home units whenever possible. We strongly encourage dens to participate in the week-long activities together, with their den leader.

The Mayflower Council offers six weeks of Adventure Day Camp. Campers may attend any week they choose. Programs operate Monday

through Friday from 9:00 AM to 4:00 PM. Extended day program is available.

### CAMP RESOLUTE REFUND POLICY

There is no risk for families of losing money by signing up for Mayflower Camps now. In the event that camp does not open or has a shortened season due to COVID-19 and your troop or campers are unable to attend during your scheduled time, all camp fees paid will be refunded. This full refund also extends to families that sign their children up for summer camp and it is not canceled but at that time of camp do not feel comfortable sending them. ## Does my child need a medical form?

Every child attending Adventure Day Camp is required to bring a BSA Health and Medical Record, parts A & B to camp with them on the first day (**DO NOT mail** it to camp or the council office). [Click here](#) to obtain a copy. These forms must be retained by camp, so **keep a copy at home** for use at other activities. Campers who must take medication while at camp must also have the authorization section of the form completed. All medications must be in original prescription bottles.

We are required by the Scouts, BSA to obtain this BSA health form for all campers. We **CANNOT** accept the doctors print out. All immunization dates **MUST** be completed on the BSA form.

## Should my child bring a lunch?

Each child is expected to provide their own lunch. The lunch should be brown bag style. We do not have access to on-site refrigeration; it is strongly recommended not to use any mayonnaise products in your child's lunch. Please do not bring coolers. Plenty of water will be provided during the day's activities.

Be sure to mark lunch boxes with your camper's name.

There will be no lunch program this year as our resident camp will not be open.

## What should I pack for my child's week at camp?

All of the equipment needed for the various activities that boys and girls will take part in

during the day is provided. Boys and girls will only need to bring a few items with them each morning. Please make sure that all personal items are labeled with your camper's name and hometown. This makes it much easier to identify lost items. Items each boy should bring to camp include:

- A MASK!
- A rain jacket is a must!
- Campers should bring their own lunch.
- Filled water bottle
- A swimsuit (one piece for girls) and towel are needed to participate in swimming and boating activities.
- The camp trading post is well stocked with souvenirs, snacks and drinks. Campers should bring their own spending money.
- Please do not bring knives, cell phones, electronic games, pokemon, magic, or other cards

A day at camp is full of running and playing, hiking and exploring the outdoors. Open-toed shoes and sandals are not appropriate foot wear for these activities and should not be worn.

## What Will My Camper Do at Adventure Day Camp?

Our program provides a variety of activities to help the Camper on their advancement trail. Boys and girls will swim every day. There is a rotating schedule during the week to work on their BB and Archery skills, play sports, work on nature and scout skills, and crafts. Each day is a spirit day, crazy hair, costume, crazy hat, facial hair Friday, and we are planning a covid appropriate 5<sup>th</sup> day.

## What if my child needs medication?

All medication must be turned in to the camp health officer upon arrival at camp. It must be in its original packaging with the original prescription label intact. Authorization to

administer medication must be given by signing the appropriate section of the camp medical form. Medications may only be administered by the camp health officer. Exceptions may be made for asthma inhalers and similar medications at the discretion of the camp health officer.

Be sure to pick up medications from our health officer when you arrive on Friday.

### **What is the camp's No-Show/Dismissal policy?**

Parents are requested to contact the camp at 978-779-5514 in the event that your camper will not be able to attend camp for one or more days. The camp staff will not release a camper into the custody of any person except the parent or legal guardians whose names appear on the camp medical form without written authorization from the parent or legal guardian. If your camper is signed-up for bus transportation and is getting a ride home from another parent including a volunteer staff member we must receive that request in writing.

### **What do I do if I need to pick my camper up early from camp?**

We ask that you contact the camp at 978-779-5514 in advance by telephone, in writing, or <mailto:adventuredaycamp@mayflowerBSA.org>. This will allow minimal disruption to our program. For the safety of our campers, any early dismissals must be before 3:30 PM to minimize the volume of moving vehicles in the parking lot. Parents will not be allowed in the camp, so call us from the parking lot when you arrive and we will bring your camper to you. Please stay in your car.

### **Where is the camp located and where can I find directions?**

The camp is located at 129 Hudson Road in Bolton, Massachusetts. E. Paul Robsham Scout

Reservation is owned and operated by the Mayflower Council. See the last page of this guide for directions.

### **What if it rains?**

We will continue all activities, unless there is severe weather in the area. Make sure your camper has all his or her rain gear in case.

### **My camper has a friend or sibling who isn't a Scout, can he or she come?**

Sign them up! They will just have to Register on line.

### **What if I can't afford camp?**

### **Do you have snack time?**

We have no special time set aside for snack but, your camper may bring a snack and eat it at anytime. Please pack it separately from lunch.

### **How many boys and girls are in a den?**

6 is the max per den this year

### **Will my camper receive awards?**

Each camper will receive a list of achievements for the week they attend. You will receive a printout with your picture at the end of the week. Scouts should turn these in to their leader to receive credit.

### **Can I visit camp before I sign-up?**

Unfortunately our camp properties are closed to visitors until the end of June and no new date has been planned for an open house.

### Does my camper have to swim if he or she doesn't know how?

We do encourage all boys and girls to go in the water. All boys and girls take a swim test on the first day of camp to check their ability.

### What if I have special concerns?

It is our goal to make sure each camper has the best experience possible. Please let us know and we will do our best to accommodate your needs!

### Does your camp comply with the Massachusetts Department of Public Health regulations?

Mayflower Council Camps comply with the regulations of the Massachusetts Department of Public Health (105 CMR 430) and we are licensed by the Nashoba Associated Boards of Health. In addition we will comply with all recommended Covid-19 Protocols.

### Is your camp an American Camp Association accredited camp?

Yes, the Adventure Day Camp and Camp Resolute at the E. Paul Robsham Scout Reservation received their ACA accreditation in November 2012 and were re-accredited in 2015 and were re-accredited in 2019.

### General Information

Our Camps offer some of the finest outdoor experiences a Scout, their friends, and parents can enjoy anywhere and here's why:

### Staff

Each of our Camping programs is administered by a Nationally Certified Camp

Director and all key staff are trained in their areas of responsibility. Our staff members are carefully selected and reflect the principles of Scouting.

## **Facilities**

---

All of our camps feature facilities in natural surroundings. Our Adventure Day Camp is held at a location that is inspected for safety, cleanliness, and program suitability.

## **Program**

---

It's easy to see the benefits of the programs we offer. Of course, fun is the top priority of every camper. But, while delivering the fun, we manage to add in equal amounts of citizenship, fitness, self-esteem, and character development that are the hallmarks of Scouting.

## **Financial Aid**

---

In order to give as many camperships as possible, it is the policy of the Mayflower Council not to give 100% camperships and to only give camperships for one week at camp. Each family is expected to share part of the expense of camp. The amount granted is made on the basis of need and availability of funds.

To apply for a campership, the below application must be submitted no later than June 1, 2019. The committee will be meeting to distribute available funds on a rolling basis beginning in early spring. The earlier an application is submitted, the better chance the applicant has of receiving assistance. There is no guarantee of campership awards and applications will not be accepted after June 15, 2020. [Campership Application](#)

## **Insurance**

---

Mayflower Council maintains an insurance policy which covers all campers while at camp. This policy is an excess policy, which means that benefits are paid in excess of the benefits paid by any other insurance which the individual or group may have. To summarize, if your Scout is injured at camp, your personal insurance becomes primary for coverage with the camp insurance picking up any remaining amount. If no other insurance is available, the council's policy will cover expenses.

## **Accreditation**

---

Each of our camps undergoes one or more safety inspections prior to and during operation. Our camp was certified as Nationally Accredited by the BSA during the 2019 summer camp season. We are also an American Camp Association Accredited Camp since 2012.

## **Cancellation of Programs**

---

The Mayflower Council reserves the right to cancel any program. Youth having made reservations for any cancelled program will be given the opportunity to make reservations for any other program being offered.

## **Non-Discrimination Policy**

---

The programs of the Mayflower Council are available to all boys and girls without regard to race, color, religion, disability, or national origin. Any youth member may attend any age appropriate camp conducted within the council.

## **Confirmation Packets**

---

The email receipt you receive after you complete your registration is the only confirmation you will receive. No further email confirmations will be sent.



The week prior to your camper's attendance, you will receive an email with any final instructions and reminders.

## Safety and Compliance

Our primary concern is the safety and well-being of every camper. Our camp follows all safety and risk management guidelines set by the Scouts, BSA of America, the local, state and federal boards of health, and the American Camp Association, a national camp organization that sets high standards for both the health and safety of campers and staff, and the delivery of quality programs. All camps in Massachusetts must comply with regulations of the Massachusetts Department of Public Health (105 CMR 430.000). In addition, the Bolton Board of Health licenses our camp.

As required by MA DPH 105 CMR 430:190 (C) and (D), our camp must comply with regulations of the Massachusetts Department of Public Health and be licensed by the local board of health. Parents may request copies of background checks, health care and discipline policies, as well as procedures for filing grievances.

American Camp Association (ACA) accreditation means that Camp Resolute cares enough to undergo a thorough annual review of its operation—more than 250 standards from staff qualifications and training to emergency management. ACA collaborates with experts from the American Academy of Pediatrics, the American Red Cross and other youth service agencies to assure that current practices reflect the most up-to-date, research-based standards in camp operation. A health officer staffs the camp health lodge and a local physician is on call.

## Medical Forms

**Every adult and Scout in camp MUST have a completely filled out medical form on file in the Health Lodge in order to stay at Camp Resolute.**

Day Camp health forms are part A & B only and no physician signature required. In addition, the immunization record for each camper, youth or adult, must include the following vaccines: Hepatitis B for all children born after December 31, 1992 (3 doses are required); Diphtheria, Tetanus Toxoids and Pertussis (at least 4 doses); MMR (2 doses or proof of laboratory evidence of immunity) and Polio (3 to 4 doses depending on the type). **No "see attachments" will be accepted.** Make certain that the parent's signature section are filled out and a copy of the health insurance card is attached to the form. Medical forms are available [online](#).

All medical forms must be retained by camp, so please make any copies you might need for other activities. Units with Christian Scientist members will need to provide a special medical form, located at [campresolute.org](http://campresolute.org), pertaining to their faith's medical policies.

### **Medications**

State regulations cover the storage and dispensing of medications. All medication must come to camp in the original containers and be stored by the health officer in locked compartments in the camp health lodge. Exceptions to storage by the health officer are authorized for medications for treatment of allergies and asthma. Questions about these medications should be raised with the camp prior to the child's arrival. To ensure a smooth transition, we recommend that your child continue the medications they need during the school year at summer camp. If prescription medications are brought to camp, the container must have a pharmacy label showing the prescription number, patient's name, date filled, physician's name, name of medication and directions for use. This information must also be on the camp medical form. Any camper coming to camp with a prescription Epi-pen or inhaler must bring two of either, one for the health lodge and one for the unit. The health officer

dispenses medication according to the directions. If a camper refuses to take prescribed medications, this refusal is documented in the health log and the parent/guardian is notified.

### **Health Care Consultant**

---

The health care consultant (HCC) is a licensed physician. The HCC assists in the development of the camp's health care policy; develops and signs written orders for the health care supervisor; and is available for consultation at all times. The health care consultant is not present at camp.

### **Health Officer**

---

An Assistant Health Officer, who is at least 18 years of age and is present at the day camp at all times. The health care consultant authorizes the health officer to be in charge of health matters at camp on a day-to-day basis and to dispense medications.

### **Health Care Policy**

---

### **Care of Mildly Ill Campers**

---



Each camper or staff member is responsible for reporting any signs of illness to the health officer (HO), who assesses each situation. The HO may administer over-the-counter medications he/she believes are warranted if they are authorized by the parent/guardian. If the HO determines the child should be sent home or seen by the health care consultant, he/she informs the reservation director and arrangements are made. In both situations, the parent/guardian is contacted as soon as possible.

### **Care of Campers who have an Illness/Accident at Camp**

---

Parents/guardians will be notified as soon as possible should a camper be taken to the doctor's office/hospital for an injury or health condition and if medication has been prescribed by the camp's health care consultant. The health officer or reservation director will notify parents/guardians of any persistent conditions or ailments. Parents/guardians should notify their doctor and health care provider of any health condition or accident/injury occurring at camp for follow-up visits and billing purposes.

We do not notify parents about minor scrapes and bumps.

### **Massachusetts Department of Public Health**

---

At the request of the Department of Public Health we have included a fact sheet on Meningococcal disease on our Camp Resolute [website](#). Campers attending a resident camp are not considered to be at an increased risk. The United States Centers for Disease Control, Massachusetts Department of Public Health and the Mayflower Council encourage everyone to be safe outdoors. Diseases associated with ticks and mosquitoes are growing threats in Massachusetts. When outdoors, please take necessary precautions as suggested by the Centers for Disease Control.

This camp must comply with regulations of the Massachusetts Department of Public Health and be licensed by the local board of health.

## Discipline

Campers attending Camp Resolute are expected to maintain appropriate behavior at all times. Respect for all members of the camp community and Resolute facilities is expected at all times. All discipline shall have as its intent the modification of behavior to within acceptable parameters. Discipline shall be limited to counseling, close supervision/monitoring, and restriction from selected activities. At no time will discipline be administered by a staff member under 18 years of age unless the actions in question pose a safety hazard to the offender or another individual. Then action appropriate to remedy the situation may be employed. Discipline shall be constructive or educational in nature, and may include such measures as diversion, separation from problem situations, talking with the camper about the situation, or praise for appropriate behavior.

Prohibitions:

- Corporal punishment, including spanking, is prohibited;

- No camper shall be subjected to cruel or severe punishment, humiliation, or verbal abuse;
- No camper shall be denied food or shelter as a form of punishment;
- No child shall be punished for soiling, wetting or not using the toilet.

The reservation director reserves the right to dismiss a camper when, in the director's judgement, the camper's behavior interferes with the rights of others, prevents the smooth functioning of a group or activity, or violates the camp's principles of conduct.

## Lost and Found

Each week we have an accumulated pile of towels, bathing suits, water bottles, etc. We strongly encourage parents to label all items with their camper's name to aid us in returning items. We will make every effort to match the items to the scouts. This year we will try to take photos of items and share for parents to identify and help us return to their owner. Parents will not be allowed into camp to look through the items. We do not save underwear or socks!

At the end of the summer all unclaimed items are washed and donated to local charities.

## Check In

When the boys and girls arrive at camp, our staff will be waiting in the parking lot to perform the pre-screening recommended by the Commonwealth. If cleared to exit the vehicle, the camper(s) get out. Monday they will be escorted to their den and then go on their own the rest of the week. them in and provide a den assignment. Each camper will be assigned a number/sign for the vehicle and a matching tag.

ALL CAMPERS ARE REQUIRED TO HAVE A MASK! All campers entering the camp must

wash their hands prior to entering the gate. A hand wash station will be set up at the gate.

Parents do not exit the vehicle or park their car.

The guidance from the Commonwealth is updated frequently and we will send parents updates as we receive them,

### Check Out

After the closing flag ceremony, campers are lined up by assigned number. Our staff will be in the parking lot to direct vehicles and call into camp for the release of the camper. Parents stay in the vehicle at all times. We will start with the 1<sup>st</sup> vehicle in line – first in first out.

### Severe Weather

With summer comes the chance of thunder storms and high temperatures. We follow very strictly, the guidelines set forth by the Scouts, BSA to ensure the safety of our campers and staff. All our staff completes a Weather Hazards course as part of their mandatory training.

### Thunder Storms

Our key staff receives a cell phone alert when there is lightening within 6 miles of our camp. We are also much attuned to hear distant thunder. In both cases, our staff will clear the water of swimmers and boats and seek shelter. Two buildings in the camp are designated as safe locations as they have windows, doors, and grounded plumbing. Our staff will lead the campers in games, crafts, sing alongs, or show a G rated movie. Normal activities can resume when there has been 30 minutes since the last audible thunder. Campers are divided into 2 facilities and we will pre-set for social distancing. Masks will be required.

### Heat Advisories

In cases of extreme heat, extreme humidity, or the combination of both, all regular program areas will be shut down. Fifty percent of the campers will be allowed to swim, while the remaining campers will be in an open-air pavilion to watch a movie. We will then flip the camp and get the other half in the water while the first group enjoys a movie.

**PLEASE NOTE:** While every attempt is made to get the remaining campers in the water, this type of weather is also accompanied by thunder storms. If this occurs, we may not be able to get everyone in the water. They will, instead, be brought inside for non-contact activities

We are on a well system which prevents us from running lawn sprinklers as a means of cooling down.

### Emergencies, Visitors, and Scouts Leaving Camp

Parents/guardians picking up campers early should call the office at 978-779-5514 to let us know. When you arrive at camp, please call us from the parking lot and your camper will be escorted to the parking lot for tag/sign matchup and release.

### CAMP OFFICE/EMERGENCY NUMBER: 978-779-5514

All serious medical emergencies will be treated at the UMass Marlboro Hospital and Parents/guardians will immediately be notified by the Health Officer, Camp Director, or his/her designee.

### Telephone

Adventure Day Camp's phone number for incoming calls is (978) 779-5514. Please keep in mind that this is primarily a business phone, for the use of the camp administration. Non-

emergency messages will be taken and delivered to the camper's den leader. We strongly suggest that campers leave cell phones and other expensive electronics at home.

### Prohibited Items

Do not send your camper to camp with aerosol bug spray, pets, or pocket knives. While our program may include Whittlin' Chip, we will provide the implements needed to teach the class. Also leave cell phones and other expensive electronics at home. No camper should bring bow and arrow or BB guns to camp as well.

### Trading Post

The Day Camp Trading Post maintains a well stocked camp store to serve everyone who is attending, or just visiting camp. We stock ice cream novelties, 100% fruit juice based slush, popcorn, chips, and assorted candies that are popular with this age group. We also have Resolute logo items, and novelty toy items.

There will be no self-serve at the trading post this year, only through a clerk.

### Extra Weeks at Camp

Do you have a Camper who wants to come for another week? Ask us about the special "Add a Week" link that will automatically apply the multiweek discount.

### Swim Tests

At the start of the camp week, we are required by the Scouts, BSA to test every camper for swimming ability. We do keep records on those tests for campers returning for multiple weeks. We encourage all campers to test to the highest ability they are comfortable with and do provide instructional swimming during the week. In addition to ability testing, all campers participate in a waterfront safety orientation.

As required by Christian's Law, all campers will be tested to the standard American Red Cross Swim Levels – details of those requirements will be added to the website [www.cubscoutcamps.org](http://www.cubscoutcamps.org) as well as direct communication to parents.

### Staff Hiring Practices

All parents have a right to know what our staff hiring practices are. All applicants are subject to a Criminal Offender Registry Inquiry, Sex Offender Record Inquiry and a check of the National Public Sex Offender Website. They are required to provide 3 written references as well. 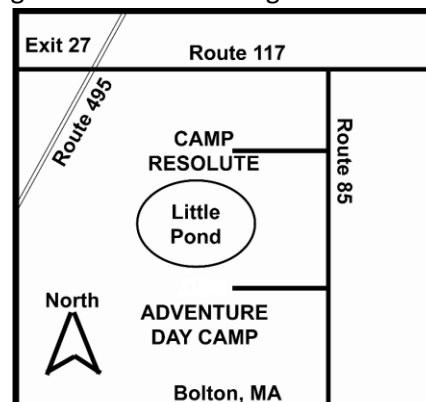
### Directions to Camp
